Requirements For Membership
Article II

SECTION 1. The Association shall consist of five (5) classes of members to wit: Active, Active Retired, Life Member, Honorary Member and Associate Member.

SECTION 2. Active members shall consist of:

- A.
 - 1. Chiefs of Police, Commissioners of Police or Superintendents of Police when recommended by an active member of this Association: and
 - 2. Assistant or Deputy Chiefs of Police, Assistant or Deputy Commissioners of Police, Assistant or Deputy Superintendents of Police, Chief Inspectors, Chief of Detectives, Assistant or Deputy Chief Inspectors, Inspectors, Deputy Inspectors, Captains and those of other ranks of Lieutenant or above who are designated as Assistant or Deputy to the Chief, Commissioner, or Superintendent of Police or who are designated as a Bureau or Division head when recommended by their Chief of Police, Commissioner of Police or Superintendent of Police, provided that individual is an active member of this Association.
 - 3. Sergeants, Lieutenants or above who are engaged in a supervisory capacity of a police department when recommended by an active member of this Association.
 - 4. The Chief of Police, Superintendent or Commanding Officer of a Railroad Police Department, charged with the responsibility of investigating violations of the law and the arrest of violators of the law, within New York State, when recommended by an active member of this Association.
 - 5. An agent-in-charge of a Federal Law Enforcement Agency, charged with the responsibility of investigating violations of law and the arrest of violators of the law, assigned to an office in New York State, when recommended by an active member of this Association.
 - 6. Other Commanding Officers or heads of police agencies as determined by the Board of Governors.
- B. Such active membership shall continue only so long as such public officials shall receive salaries from the public funds or be employed by police agencies authorized by law to be maintained. In the event an active member becomes unable to continue to meet the qualifications for active membership, the member shall be transferred to that class of membership for which the member qualifies.
- Any questions concerning appropriate classification of membership shall be referred to and determined by the Board of Governors.
- C. A further qualification for active membership shall be that the applicant is salaried and engaged on a full time basis in law enforcement and such applicant shall be a resident of New York State or have an office therein. An active member who is removed from New York State may elect to become an associate member.
- D. Any chief of police appointed under the provisions of civil service laws, rules and regulations of New York State shall be eligible for membership.
